FROM NORTH via 35W
I-35W S to Cleveland Ave North
Use the left 2 lanes to take exit 23B for Cleveland Ave/MN-36
Take exit 23B from I-35W S
Continue straight onto Cleveland Ave North
Turn left onto Commonwealth Ave
Continue onto West Dan Patch Ave
Turn right onto Liggett Street
Turn left onto Judson Ave
Destination will be on the right

FROM SOUTH via 35W (*Or from West on I-94)
Take I-35W N towards St. Paul
Take exit 16B to merge onto I-94 E toward St. Paul
**Use the left lane to take exit 236 for MN-280
Continue onto MN-280 N
Exit onto Energy Park Drive toward Kasota Ave
Turn right on Energy Park Dr.
Turn left on to Raymond Ave
Turn right onto Como Ave
Turn left onto Stevens St
Turn right onto Judson Ave
Destination will be on the right

FROM EAST ON I-94

Exit 238 for Minnesota 51/ Snelling Ave
Right lane merge onto St. Anthony Ave
Right on Snelling Ave
At Como Avenue Exit turn left
Right on Stevens St/ Right on Judson Ave
Coliseum is on the right
